Terms & Conditions

- Once we have met to discuss your day and dates, we require a \$500 non-refundable holding fee. This ensures the date, time, and services are held for you. The holding fee will be subtracted from the final invoice for our services and is not refundable even in the event of a cancellation.
- Payment is to be made in full 30 days prior to the wedding date. If discussed, it is possible to pay in two deposits, however the invoice must be paid in full 30 days prior to the wedding date. Payment is accepted in cash or bank transfer following payment details on the invoice.
- In the event of the wedding being cancelled, we will supply a full refund (minus the \$500 holding fee) up to 1 week before the wedding. If cancellation occurs 1 week or less before the day of the wedding, we will supply a 60% refund.
- In the event of the wedding being rescheduled, we will not supply any refunds. The deposits made will be used as credit towards your new date.
- In the event that one of us cannot attend the wedding (i.e. sickness, emergency), we will try our best to find a suitable replacement and run them by you before we attend. If they aren't to your liking we can process a partial refund and just one of us will attend.
- Film photography can be temperamental and unknown, a part of what makes this medium magical. We are an experienced team and ensure premium quality equipment is being used, however the process isn't impervious and there is a chance something could go wrong along the way. In the unlikely event of blank or impaired film, we can offer a refund based on the percentage of assets lost. However, we cannot refund film and developing costs, as this is a part of shooting on film. We prefer to provide digital and film photography services to ensure all bases are covered and no moments are lost.
- We promise to do our absolute best to capture everyone & everything you desire on your special day. We will initiate family shots and try get everyone involved, however will not push people who don't want to be photographed & ask that you please advise all relatives to try work with us to get all the family shots you need!

- Under the Copyright and Design Act 1988, any images and copies of images stored digitally, printed or on computer files remain the copyright of Zali Rae and Montana Purchase Weddings. You are more than welcome to use all images for personal, non-commercial purposes including display on personal websites, social media, printing for self and gifts. Any commercial use will require written permission. We retain the right to use any images for personal and commercial use, however we respect your privacy and any commercial use will be discussed first.

- A gallery will be provided with the photos of your big day within 8 weeks. This gallery will be available online for 30 days and must be downloaded during this time. In the event of you losing the images, a reasonable fee will be incurred for the time taken to re-upload the gallery. We cannot ensure all images will be available after this date.

- For services over 5 hours that include photographing the reception, a meal should be provided. For travel time over 2 hours, an hourly rate of \$30 is required to cover petrol and car allowance, as well as any additional travel expenses agreed to (i.e. flights). If the travel time home is after midnight, suitable accommodation is required.
